



PUBLIC NOTICE

WRITTEN CONSULTATION PROCEDURE ON THE DRAFT REGULATION 25.36-2020 AND ON THE DRAFT REGULATION 23.9-2020

Public notice is given by the undersigned, Georges Lazurka, director general and secretary-treasurer of the Municipality of Ormstown, to all taxpayers of the municipality to the effect:

- THAT in accordance with the provisions of the ministerial order of August 17, 2020 number 2020-058, of the Minister of Health and Social Services, made under the Public Health Act (RLRQ, c. S-2.2), the projects of the above-mentioned regulations will be subject to a written consultation procedure of fifteen (15) days from the publication of this notice, replacing the public consultation, the citizens having previously been notified by mail of this procedure;
- THAT during the regular Council meeting held on August 3, 2020, there was adoption of draft By-law # 25.36-2020 amending Zoning By-law # 25-2006 and draft By-law # 23.9-2020, amending the By-law of subdivision # 23-2006.

1. Objects of draft By-law # 25.36-2020

The purpose of draft Regulation # 25.36-2020 is to:

- a) Correct clerical errors noted in Zoning By-law # 25-2006;
- b) Correct errors in the usage grids;
- c) Add definitions to Zoning By-law # 25-2006;
- d) Add architectural standards for portals;
- e) Review the amount of fines for violations of Zoning By-law # 25-2006;
- f) Comply with the development plan by prohibiting uses that are not named in agricultural type assignment 1 (A1).

2. Objects of draft By-law # 23.9-2020

The purpose of draft Regulation # 23.9-2020 is to:

- a) Review the amount of fines for violations of Subdivision By-law # 23-2006;

3. Written public consultation.

The written public consultation runs from September 9 to September 24, 2020, inclusive. During this written consultation, you can share your questions and comments on the draft regulation.
